1. User test: a. Presses ON. Note: To perform the user test, ignore all REMOVE TEST PLUG prompts and keep the test plug connected. b. Presses OPTIONS. If the defibrillator is in AED mod switch to manual mode and then press OPTIONS. c. Selects USER TEST. d. Selects YES to initiate user test.	le,				
 2. Therapy cable test: a. Confirms therapy cable is connected to the defibrillat b. If QUIK-COMBO therapy cable is connected: Confirms test plug is connected to therapy cable. Presses ANALYZE, look for the REMOVE TEST PLUG message. c. If hard paddles are connected: Confirms paddles are properly seated in wells. Selects 10J and presses CHARGE button. When fully charged presses SHOCK button on paddles, and look for ENERGY DELIVERED message.  3. Changing recording paper: a. Presses the black button to open the printer door. b. Inserts the new paper roll onto raised spool brackets with grid facing forward. c. Pulls out a short length of paper. d. Pushes the printer door in to close. 	S				
4. Entering patient data: a. Presses OPTIONS and selects <i>PATIENT</i> . b. To enter or edit a patient's name or ID: Select LAST NAME, FIRST NAME, or ID, Rotate the Speed Dial

 5. Accessing reports: a. Presses OPTIONS and selects ARCHIVES. b. Selects YES to enter the patient archives. c. Selects PRINT. To exit the archives mode, turn off the device. 			
 6. Cleaning: Verbalizes the cleaning of the LIFEPAK 20/20e defibrillator/monitor, cables and accessories with a damp cloth, using only the following agents: • Quarternary ammonium compounds. • Isopropyl alcohol. • Peracetic (peroxide) acid solutions.
